Accordingly, in compliance with the aforesaid MCA Circulars, postal ballot forms and pre-paid business envelopes are not being sent to Members for this Postal Ballot. This Postal Ballot Notice is being sent only through electronic mode to those Members whose email address is registered with the Company/RTA/ depository participant(s)/ Depositories. The details of the procedure to cast the vote forms part of the 'Notes' to this Notice. If your e-mail address is not registered with the Depositories, please follow the process provided in the Notes to this Notice, to receive this Postal Ballot Notice and login ID and password for e-voting. The communication of the assent

or dissent of the Members would only take place through the e-voting.
